Also, Duluth Police are still seeking the public's help in locating **JESSE LEE MUELLNER, DOB 10/04/1990**. He was listed as the DULUTH POLICE "Property Crimes Wanted Person of the Week on November 29th, 2012.

Jesse Muellner has **FOUR** warrants for his arrest, **TWO** of which are felony warrants. The first is for violation of probation stemming from a 5th degree possession of a controlled substance case and the second is for failure to appear on check forgery charges.

UPDATE:

On Thursday, December 13th, 2012 at 1:29 PM Duluth Police put out a press release seeking the public's assistance in locating Haley Engstad and Jesse Muellner. At 3:07 PM Duluth Police received a tip that they were both in Superior, Wisconsin. We relayed the tip to the Superior Police Department. At 8:50 PM the Superior Police Department officers located and arrested Engstad and Muellner without incident at an address in the 3200 block of Belknap Street. Both were transported to the Douglas County Jail and lodged on the Saint Louis County warrants and remain there pending extradition.
